- 1. Sells, exchanges, options or purchases a business;
- 2. Negotiates or offers, attempts or agrees to negotiate the sale, exchange, option or purchase of a business; or
- 3. Lists or solicits prospective purchasers of a business.

APPLICATION : Complete and sign the business broker application.
<u>FEE</u> : The Business Broker Permit application fee is \$40.00 . Make checks payable to the Nevada Real Estate Division. Cash in exact change and credit cards are accepted for in person counter transactions.
EXAM : Original exam results (for exam scheduling, contact Pearson VUE testing service: http://www.pearsonvue.com/nv/realestate/ , or call: (888) 248-8055).
EDUCATION : Attach proof of an approved 24 hour Nevada Business Brokerage course. Distance learning courses as deemed equivalent by the division are accepted. A list of real estate schools that offer this course is located on the NRED web site http://red.nv.gov/. See Form 502 for course information.
FINGERPRINTS : Attach one finger print card and a \$36.25 cashier's check or money order made payable to the Department of Public Safety. A personal check or cash will not be accepted. -OR- Attach verification of prints taken electronically by an approved vendor. The approved vendor list is

Fingerprint Background Waiver

As an applicant who is the subject of a Federal Bureau of Investigation (FBI) fingerprint-based criminal history record check for a noncriminal justice purpose you have certain rights which are discussed below.

 - **16.34 Procedure to obtain change, correction or updating of identification records.** If, after reviewing his/her identification record, the subject thereof believes that it is incorrect or incomplete in any respect and wishes changes, corrections or updating of the alleged deficiency, he/she should make application directly to the agency which contributed the questioned information.
