12 **ORDER**

13 This matter came on for hearing before the Commission for Common-Interest
14 Communities and Condominium Hotels, Department of Business and Industry, State of
15 Nevada (the "Commission"), during a regular agenda on August 28, 2018, at the Nevada
16 State Business Center, 3300 W. Sahara Avenue, Nevada Room, Suite 400, Las Vegas,
17 Nevada 89102 with videoconferencing to Department of Business & Industry, Division of
18 Insurance, 1818 East College Parkway, Carson City, Nevada 89706 (the "Hearing").
19 Respondent Diamond Creek Homeowners Association appeared through its community
20 manager, Edwina Daly. Michelle D. Briggs, Esq., Senior Deputy Attorney General with
21 the Nevada Attorney General's Office, appeared on behalf of the Real Estate Division of
22 the Department of Business and Industry, State of Nevada (the "Division").


23 Ms. Daly reported the Association's audit is still in progress due to problems with
24 record keeping by the prior manager. The prior manager stopped posting payments in
25 May 2017. They are trying to recreate the records. The reserve fund is overfunded, but
26 some work does need to be done, including slurry sealing the streets. The board is
27 currently getting bids and working on that process.

28 The Commission ORDERED that the Association provide the audit to Ms. Briggs
within 90 days of the date of this Order and report back to the Commission in 180 days.
