## ORDER DISMISSING CASE

This matter came on for hearing before the Commission for Common-Interest Communities and Condominium Hotels, State of Nevada (the "Commission"), during a regular agenda on August 4, 2020, via telephone and video with no physical public location (as permitted by the Governor's Declaration of Emergency, Directive 006, as extended by Directive 029). Respondent LISA TUFANO ("RESPONDENT") appeared on her own behalf, and Karissa D. Neff, Esq., Deputy Attorney General with the Nevada Attorney General's Office, appeared by video on behalf of the Real Estate Division of the Department of Business and Industry, State of Nevada (the "Division"). RESPONDENT did not file an answer to the Complaint. The Division sent RESPONDENT a Notice of Default on May 1, 2020.

The Commission, having considered the evidence introduced by the Division and being fully advised, enters the following Findings of Fact, Conclusions of Law, and Order. Under Nevada Revised Statutes (NRS) and Nevada Administrative Code (NAC) Chapter 116A, the Commission has legal jurisdiction and authority over this matter.

WHEREAS, the Commission, by unanimous vote finds that the Division did not meet its burden of proving the Factual Allegations detailed in the Complaint by a preponderance of the evidence; and

WHEREAS, based on the foregoing, the Commission concluded by unanimous vote

1	that RESPONDENT did not commit the violations of law detailed in the Complaint.
2	THEREFORE, the Commission hereby orders that this case be DISMISSED against
