ORDER APPROVING STIPULATION FOR SETTLEMENT OF DISCIPLINARY ACTION

This matter came on for hearing before the Nevada Real Estate Commission, Department of Business and Industry, State of Nevada ("Commission") on February 28, 2013. at the Henderson City Hall, Council Chambers Conference Room, 240 Water Street, Henderson, Nevada. Respondent Catherine C. Ramus ("RESPONDENT") and her attorney, Pamela Lawson, appeared at the hearing. Kimberly Arguello, Senior Deputy Attorney General, appeared and prosecuted the Complaint on behalf of the Administrator of the Real Estate Division, Department of Business & Industry, State of Nevada ("Division").

After the Commission failed to approve the parties' written Stipulation for Settlement of Disciplinary Action, RESPONDENT and the Division verbally agreed to a revised settlement. Having considered that verbal settlement, the Commission hereby approves its terms. Consequently, pursuant to a vote of four to one:

IT IS HEREBY ORDERED that RESPONDENT shall pay to the Division a total fine of \$14,000.00. RESPONDENT shall pay \$7,000.00 of the fine to the Division within thirty (30) days of the effective date of this Order. RESPONDENT shall pay the remaining \$7,000.00 of the fine to the Division in \$250.00 monthly installments commencing thirty (30) days of the effective date of this Order, and continuing with \$250.00 monthly payments until the balance is paid. The Division may institute debt collection proceedings for failure to timely pay the total fine.

1	IT IS FURTHER ORDERED that RESPONDENT's real estate license and property
2	management permit are hereby REVOKED.
3	The Commission retains jurisdiction for correcting any errors that may have occurred in
4	the drafting and issuance of this Decision.
