Dear Ms. Hardin,

Please accept this letter as a request for a re-hearing and to be placed on the agenda for the August 15 & 16th, 2017 session.

I'd like to plead an oral argument to consider either the lifting or reduction of my imposed 1 year suspension based on my existing inability to gain meaningful employment due to my age (59), my handicap/disability and my family (6) income which cannot support our current bills to the degree that we are on State Benefits & Assistance through The Department of Health and Human Services.

I'm also pleading a reduction of fines imposed, an extended time allowed to pay and to be placed on a reasonable plan to pay my obligation to the Real Estate Division. It would be very difficult to pay such a large fine without the re-instatement of my Real Estate License.

Until my Effective Due Date of January 19, 2018, I'd like to propose paying a minimum of \$100 per month.

Finally, I'd like the opportunity to present letters of support from North Las Vegas Mayor John Lee, Congressman Ruben Kihuen and others with whom I have personal friendships with as to reflect the integrity established in my community encompassing countless hours volunteering time as:

Board Chairman for the City of North Las Vegas Parks & Recreation which oversees the financial and decisions and oversight of 36 parks, including Kiel Ranch, Craig Ranch and Aliante Golf Course. I was re-appointed to another 2 years, by Mayor John Lee, this past June, 2017.

President of North Las Vegas Democratic Club, which I currently serve in an elected 2 year term. Our monthly meetings are held at the North Las Vegas Police Officers Association building at 3425 West Craig Road with the blessing of NLV Police Chief Alex Perez who donates the space at no charge.

Former President of The North Valley Dems.
