COMPLAINT AND NOTICE OF HEARING

The REAL ESTATE DIVISION OF THE DEPARTMENT OF BUSINESS AND INDUSTRY OF THE STATE OF NEVADA (“Division”), by and through its counsel, Aaron D. Ford, Attorney General of the State of Nevada, and Dennis L. Belcourt, Deputy Attorney General, hereby notifies RESPONDENT BARRY M. ROSS (“RESPONDENT”) of an administrative hearing before the STATE OF NEVADA REAL ESTATE COMMISSION. The hearing will be held pursuant to Chapters 233B and Chapter 645 of the Nevada Revised Statutes (“NRS”) and Chapter 645 of the Nevada Administrative Code (“NAC”). The purpose of the hearing is to consider the allegations stated below and to determine if the RESPONDENT should be subject to an administrative penalty as set forth in NRS 645.633, NRS 645.630 and NRS 622.400, and the discipline to be imposed, if violations of law are proven.

JURISDICTION

In conducting activities alleged herein, RESPONDENT engaged in activities which require a license as a real estate broker, real estate broker-salesperson, or real estate salesperson, issued by the Division and is, therefore, subject to the jurisdiction of the Division and the Commission, and the provisions of NRS chapter 645 and NAC chapter 645.

FACTUAL ALLEGATIONS

1. At all times relevant to this Complaint, RESPONDENT held a license as a salesperson, S.0179946.

4 **NOTICE OF HEARING**

5 **PLEASE TAKE NOTICE** that a disciplinary hearing has been set to consider the Administrative
6 Complaint against the above-named Respondent in accordance with Chapters 233B and 645 of the
7 Nevada Revised Statutes and Chapter 645 of the Nevada Administrative Code.

8 **THE HEARING WILL TAKE PLACE on November 5, 2019 commencing at 9:00 a.m., or**
9 **as soon thereafter as the Commission is able to hear the matter, and each day thereafter**
10 **commencing at 9:00 a.m. through November 7, 2019 or earlier if the business of the Commission is**
11 **concluded. The Commission meeting will be held on November 5, 2019, at the Nevada State**
12 **Business Center, 3300 West Sahara Avenue, 4th Floor – Nevada Room, Las Vegas, Nevada 89102.**
13 **The meeting will continue on November 6, 2019 at the Nevada State Business Center, 3300 West**
14 **Sahara Avenue, 4th Floor – Nevada Room, Las Vegas, Nevada 89102, commencing at 9:00 a.m.,**
15 **and on November 7, 2019, should business not be concluded, starting at 9:00 a.m. at the Nevada**
16 **State Business Center, 3300 West Sahara Avenue, 4th Floor – Tahoe Room, Las Vegas, Nevada**
17 **89102.**

18 **STACKED CALENDAR: Your hearing is one of several hearings scheduled at the same**
19 **time as part of a regular meeting of the Commission that is expected to last from November 5, 2019**
20 **through November 7, 2019, or earlier if the business of the Commission is concluded. Thus, your**
21 **hearing may be continued until later in the day or from day to day. It is your responsibility to be**
22 **present when your case is called. If you are not present when your hearing is called, a default may**
23 **be entered against you and the Commission may decide the case as if all allegations in the complaint**
24 **were true. If you have any questions please call Evelyn Pattee, Commission Coordinator (702) 486-**
25 **4074.**

26 **YOUR RIGHTS AT THE HEARING:** except as mentioned below, the hearing is an open meeting
27 under Nevada’s open meeting law, and may be attended by the public. After the evidence and arguments,
28 the commission may conduct a closed meeting to discuss your alleged misconduct or professional

1 competence. You are entitled to a copy of the transcript of the open and closed portions of the meeting,
2 although you must pay for the transcription.

3 As the Respondent, you are specifically informed that you have the right to appear and be heard
4 in your defense, either personally or through your counsel of choice. At the hearing, the Division has the
5 burden of proving the allegations in the complaint and will call witnesses and present evidence against
6 you. You have the right to respond and to present relevant evidence and argument on all issues involved.
7 You have the right to call and examine witnesses, introduce exhibits, and cross-examine opposing
8 witnesses on any matter relevant to the issues involved.

9 You have the right to request that the Commission issue subpoenas to compel witnesses to testify
10 and/or evidence to be offered on your behalf. In making the request, you may be required to demonstrate
11 the relevance of the witness' testimony and/or evidence. Other important rights you have are listed in
12 NRS 645.680 through 645.990, NRS Chapter 233B, and NAC 645.810 through 645.920.


13 The purpose of the hearing is to determine if the Respondent has violated NRS 645 or NAC 645
