**Special Note:** We have received the final results from the AMC Program Review in September, and we received a rating of "Good". The Appraiser Program results are still pending as there has been some recent turnover in the ASC.

As of December 31st, 2025, there are 8 investigations that have exceeded the 365-day mark. Of those 8, there are 2 cases out for Standard 3 Review (pending completion) and 2 cases were forwarded to the Attorney General's office for the January CARE agenda. Of the remaining 4, there are 3 cases that have completed Standard 3 Reviews and are pending final Investigator findings, and one that needs to be sent out for a Standard 3 Review.

The new Discipline Matrix that was implemented earlier this year is proving to be effective. We have successfully completed 2 Conditional Dismissals this year and received positive feedback from the Respondents regarding the process.

In September we welcomed Barry Chappell as our Program Officer II, a newly created position within the Appraisal program. Barry oversees the Appraisal and Inspectors Education Programs, as well as many other administrative tasks for our section. Most recently he has taken on the task of resurrecting the Appraisal and Inspectors newsletter and is hoping to publish the first new edition since 2021, later this month.
