Southern Nevada Health District

I serve as a Hearing Officer and adjudicate cases where Solid Waste Management Authority and Hotel/Restaurant violations may have occurred as defined by NRS 444.621 – NRS 444.645. I authorize fines and sign orders for corrective action to ensure environmental compliance and public health. I encourage compromise resolutions among disputing parties. These meetings are open to the public and comply with “Nevada’s Open Meeting Laws”, NRS 241.020. I also analyze data and documents provided by staff.

Department of Business and Industry

I conduct mediations and draft agreements based on the outcome of mediation issues addressing: 1.) The interpretation of NRS, application or enforcement of CC&R’s covenants, conditions or restrictions applicable to residential property or any bylaws, rules or regulations adopted by an association. 2.) I contact the parties for the purposes of scheduling mediation and notify them to provide the mediator a written statement which sets forth the issues. 3.) I review all supporting documents provided by the parties and NRED and schedule mediations in a manner that adheres to all statutes and policies mandated by NRS 38 (as amended by AB370), NRS 116, NRS 116A, NAC 116, and NAC 116D.

Nye County Air Quality Control

I serve as a Hearing Officer and I adjudicate cases related to Air Quality Control, Fugitive Dust, PM¹⁰ and PM^{2.5}. I authorize fines and I sign corrective action orders to ensure environmental compliance. I encourage compromise resolutions among disputing parties. These meetings are open to the public and comply with “Nevada’s Open Meeting Laws”, NRS 241.020. I analyze data and documents provided by staff. I also train new Hearing Officers.

Henderson Mediation Center

I mediate issue between neighbors. Homeowners and community harmony are the primary objectives of mediation. A significant percentage of the cases are referred by the Community Affairs Division.
