12 **ORDER GRANTING RESPONDENT’S REQUEST FOR RECONSIDERATION**

13 This matter came on for hearing before the Nevada Commission of Appraisers of Real Estate (the
14 “Commission”), on Tuesday, April 23, 2024 (the “Hearing”). Nathan S. Slaman (“Respondent”)
15 appeared in person on his own behalf. Christal Park Keegan, Esq., Deputy Attorney General with the
16 Nevada Attorney General’s Office, appeared on behalf of Petitioner Sharath Chandra, Administrator of
17 the Real Estate Division, Department of Business and Industry, State of Nevada (the “Division”).

18 On or about January 25, 2024, Respondent filed a request for reconsideration of his education
19 requirement pursuant to the Stipulation and Order for Global Settlement of Disciplinary Actions on
20 January 31, 2023. On March 18, 2024, the Division filed its Motion to Dismiss Respondent’s Request
21 for Reconsideration.

22 The matter having been submitted for decision based on the Commission’s consideration of the
23 oral arguments presented during the hearing and the filed documents, the Commission now enters its
24 Order.

25 **ORDER**


26 **IT IS HEREBY ORDERED** that Respondent’s Request for Reconsideration is GRANTED, with
