STIPULATION AND ORDER TO CONTINUE

IT IS HEREBY STIPULATED AND AGREED by and between the parties hereto that:

1. The Respondents have held a vote per the Bylaws and CC&Rs and a Community Manager has been chosen and approved. Prime Management is the Community Manager. The Board is finalizing the contract with Prime Management.
2. Prime Management will assist the Board with an election for the three Board seats pursuant to the Bylaws and CC&Rs. Two owners have expressed an interest in serving on the new Board. The governing documents require three Board Members. The current Board is soliciting owners for a third volunteer.
3. Respondents Berliner, Creamer, Zambrano and Carter will voluntarily step down from their Board positions, and will not run for a seat on the Board in the current election. They will step down immediately after the election of new Board members. They further will be precluded from seeking a seat on the Board for a period of five years;


