SUMMARY—Revises provisions relating to business entities. (BDR 7-493)

AN ACT relating to business entities; revising provisions relating to service of process on management persons; making various changes to definitions relating to corporations; authorizing a corporation to include a federal forum selection clause in its articles of incorporation or bylaws; revising provisions relating to the breach of a fiduciary duty by a director or officer of a corporation; making various changes relating to meetings of stockholders held by means of remote communication; revising provisions relating to voting agreements of stockholders; revising provisions relating to notice of meetings of stockholders; **revising provisions relating to insolvent corporations;** revising provisions relating to discretionary indemnification of directors, officers, employees and agents of corporations; providing an exception to the requirement that a corporation issue a certificate of membership; establishing and revising provisions relating to distributions made by limited-liability companies; **revising provisions relating to the form of contributions to capital of members of a limited-liability company or series;** making various changes relating to the standard of voting for actions taken by corporations, limited partnerships and limited-liability companies; revising provisions relating to dissenter’s rights; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law establishes various provisions relating to business entities, including private corporations and limited-liability companies. (Chapters 78 and 86 of NRS) This bill revises certain provisions relating to business entities and makes certain other changes generally relating to business entities.

Section 1 of this bill removes the requirement that a clerk of the court mail to certain management persons of a business entity true and attested copies of the process served on the registered agent of the entity, and instead requires that the party serving the registered agent mail to such management persons a copy of any document served upon the registered agent.

Section 38 of this bill repeals the selectively applicable definitions of “market value,” “publicly traded corporation,” “resident domestic corporation” and “Securities Exchange

11 Act.” respectively, and replaces the definitions in **section 2** of this bill in order to expand the
12 applicability of such definitions to the entirety of chapter 78 of NRS. **Sections 3, 7 and 8** of
13 this bill make conforming changes related to the definition of the “Securities Exchange Act.”

14 **Section 4** of this bill authorizes a corporation to include a federal forum selection clause
15 in its articles of incorporation or bylaws under certain circumstances.

16 **Section 5** of this bill expressly provides that the directors and officers of a corporation
17 may consider one or more facts, circumstances, contingencies or constituencies when
18 exercising their respective powers.

19 **Section 6** of this bill revises the definition of “distribution,” as it relates to distributions
20 made by corporations, by delineating that the term applies to ~~the~~ all holders of shares of any
21 one or more classes or series of the capital stock of the corporation. **Sections 9 and 10** of this
22 bill make conforming changes related to distributions made by corporations.

23 **Section 11** of this bill authorizes a meeting of stockholders to be held solely by means of
24 remote communication unless otherwise prescribed by the board of directors. **Section 11** also
25 provides that, in addition to the stockholders, the corporation may ~~authorize~~ permit certain
26 other persons to attend the remote meeting. Moreover, **section 11** provides that the
27 corporation must implement measures to verify the identity of the ~~authorized~~ permitted
28 persons.

29 **Section 12** of this bill provides that the record date for a meeting of stockholders of ~~the~~
30 the corporation: (1) must be fixed through a resolution adopted by the board of directors; and
31 (2) must not precede the ~~date~~ day on which the resolution is adopted by the board of
32 directors, regardless of the effective date of the resolution.

33 **Section 12** also provides that the date upon which the stockholders of record are entitled
34 to give written consent for certain actions taken by the corporation must not precede the ~~date~~
35 day on which the resolution fixing such a date is adopted by the board of directors, regardless
36 of the effective date of the resolution.

37 **Section 13** of this bill: (1) establishes provisions concerning the validity and
38 enforceability of certain voting agreements; and (2) revises provisions relating to the
39 limitation on the duration of certain voting agreements.

40 **Section 14** of this bill revises the form of notice for meetings of stockholders by requiring
41 the notice to include the following information: (1) the date of the meeting; (2) if the meeting
42 is to be held by means of remote communication, the form of the remote communication; and
43 (3) if the meeting is not going to be held solely by means of remote communication, the
44 physical location of the meeting. **Section 14** additionally applies these changes to the form of
45 notice required for adjourned meetings of stockholders.

46 **Section 14** also: (1) revises provisions related to notice by publication; and (2) establishes
47 provisions authorizing certain publicly traded corporations to provide notice by proxy
48 statement under certain circumstances.

49 **Section 14.5 of this bill expressly provides that whenever a corporation is insolvent**
50 **and in certain other circumstances, any creditors holding at least 10 percent of the**
51 **outstanding indebtedness, or stockholders owning at least 10 percent of the outstanding**
52 **stock entitled to vote, may petition a district court for a writ of injunction and the**
53 **appointment of receivers or trustees.**

54 **Section 15** of this bill expands the circumstances by which a corporation may
55 discretionally indemnify a person who is or was a party to an action, or threatened to be made
56 a party to an action, by authorizing the corporation to indemnify any such person who is or
57 was serving at the request of the corporation as a manager of ~~another corporation or business~~
58 entity a limited-liability company.

59 **Section 16** of this bill provides exception for corporations that are associations or unit-
60 owners’ associations from the requirement that corporations issue a certificate of membership
61 to any person who becomes a member of the corporation.

62 **Section 19** of this bill defines the term “distribution” for the purposes of **section 21** of
63 this bill concerning noneconomic members of limited-liability companies and **sections 23 and**
64 **24** of this bill relating to the circumstances by which a limited-liability company is authorized
65 to or prohibited from making distributions and certain other provisions of law relating to
66 limited-liability companies.

67 **Sections 22 and 25-27** of this bill require that a vote of approval for certain actions taken
68 by a limited-liability company be determined by a specified proportion “in interest” of the
69 members, as defined by **section 18** of this bill. **Section 38** makes a conforming change by

70 repealing the definitions of the term “majority in interest.” ~~[Sections 17 and]~~ **Section 20** of
 71 this bill ~~[make]~~ **makes a** conforming ~~[changes]~~ **change** relating to the placement of **section 18**
 72 in the ~~[NRS.]~~ **Nevada Revised Statutes.**

73 Section 22.5 of this bill provides that the provisions concerning the form of
 74 contributions to capital of a member of a limited-liability company or a series apply to
 75 the entirety of chapter 86 of NRS.

76 **Section 32** of this bill provides the circumstances under which a vote of the stockholders
 77 of a domestic corporation is not required to authorize a merger in which the corporation is a
 78 constituent entity.

79 **Section 33** of this bill provides that a plan of merger, conversion or exchange involving a
 80 domestic limited partnership must be approved, in relevant part, by a majority of the total
 81 contributions of the limited partners.

82 **Section 34** of this bill provides that a plan of merger, conversion or exchange involving a
 83 domestic limited-liability company must be approved by: (1) a majority of the total
 84 contributions of the members, if there is one class of members; or (2) a majority of the total
 85 contributions of each class of members, if there are two or more classes of members.

86 **Section 35** of this bill revises the applicability of the limitations on dissenter’s rights.

87 **Section 36** of this bill makes various changes related to the notification of stockholders
 88 concerning corporate actions creating dissenter’s rights, including, without limitation,
 89 authorizing a domestic corporation to send an advance notice statement to the stockholders if
 90 a proposed corporate action creating dissenter’s rights is submitted for approval ~~[by the]~~
 91 pursuant to a written consent of the stockholders or taken without a vote of the stockholders.

92 **Section 37** of this bill makes various changes to provisions related to the prerequisites for
 93 a demand by a stockholder for payment of ~~[his or her]~~ **the shares [] of the stockholder,**
 94 including requiring such a stockholder to file a statement of intent under certain
 95 circumstances.

96 **Sections 29 and 30** of this bill define the terms “advance notice statement” and
 97 “statement of intent,” respectively. **Section 31** of this bill makes conforming changes related
 98 to the placement of the definitions in the ~~[NRS.]~~ **Nevada Revised Statutes.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 75.160 is hereby amended to read as follows:

2 75.160 1. Every nonresident of this State who, on or after October 1, 2013,
 3 accepts election or appointment, including reelection or reappointment, as a
 4 management person of an entity, or who, on or after October 1, 2014, serves in such
 5 capacity, and every resident of this State who accepts election or appointment or
 6 serves in such capacity and thereafter removes residence from this State shall be
 7 deemed, by the acceptance or by the service, to have consented to the appointment
 8 of the registered agent of the entity as an agent upon whom service of process may
 9 be made in all civil actions or proceedings brought in this State by, on behalf of or
 10 against the entity in which the management person is a necessary or proper party, or
 11 in any action or proceeding against the management person for a violation of a duty
 12 in such capacity, whether or not the person continues to serve as the management
 13 person at the time the action or proceeding is commenced. The acceptance or the
 14 service by the management person shall be deemed to be signification of the
 15 consent of the management person that any process so served has the same legal
 16 force and validity as if served upon the management person within this State.

17 2. Service of process must be effected by serving the registered agent with a
 18 true copy in the manner provided by law for service of process. In addition, the
 19 ~~[clerk of the court in which the civil action or proceeding is pending]~~ **party serving**
 20 **the registered agent** shall, within 7 days after **such** service, send by registered or
 21 certified mail, postage prepaid, ~~[true and attested]~~ copies of the ~~[process,]~~

1 *documents served upon the registered agent*, together with a statement that service
2 is being made pursuant to this section, addressed to the management person at the
3 address as it appears on the records of the Secretary of State, or if no such address
4 appears, at the address last known to the *servicing party* . ~~{desiring to make the~~
5 ~~service.}~~

6 3. The appointment of the registered agent is irrevocable. If any entity or
7 management person fails to appoint a registered agent, or fails to file a statement of
8 change of registered agent pursuant to NRS 77.340 before the effective date of a
9 vacancy in the agency pursuant to NRS 77.330 or 77.370, on the production of a
10 certificate of the Secretary of State showing either fact, which is conclusive
11 evidence of the fact so certified to be made a part of the return of service, or if the
12 street address of the registered agent of the entity is not staffed as required pursuant
13 to NRS 14.020, which fact is to be made part of the return of service, the
14 management person may be served with any and all legal process, or a demand or
15 notice described in NRS 14.020, by delivering a copy to the Secretary of State or, in
16 the absence of the Secretary of State, to any deputy secretary of state, and such
17 service is valid to all intents and purposes. The copy must:

18 (a) Include a specific citation to the provisions of this section. The Secretary of
19 State may refuse to accept such service if the proper citation is not included.

20 (b) Be accompanied by a fee of \$10.

21 ➤ The Secretary of State shall keep a copy of the legal process received pursuant to
22 this section in the Office of the Secretary of State for at least 1 year after receipt
23 thereof and shall make those records available for public inspection during normal
24 business hours.

25 4. In all cases of service pursuant to subsection 3, the defendant has 40 days,
26 exclusive of the day of service, within which to answer or plead. Before such
27 service is authorized, the plaintiff shall make or cause to be made and filed an
28 affidavit setting forth the facts, showing that due diligence has been used to
29 ascertain the whereabouts of the management person to be served, and the facts
30 showing that direct or personal service on, or notice to, the management person
31 cannot be made.

32 5. If it appears from the affidavit that there is a last known address of the
33 management person, the plaintiff shall, in addition to and after such service on the
34 Secretary of State, mail or cause to be mailed to the management person at such
35 address, by registered or certified mail, a copy of the summons and a copy of the
36 complaint, and in all such cases the defendant has 40 days after the date of the
37 mailing within which to appear in the action.

38 6. Service pursuant to subsection 3 provides an additional manner of serving
39 process, and does not affect the validity of any other valid service.

40 7. In any action in which any management person has been served with
41 process pursuant to subsection 2, the time in which a defendant is required to
42 appear and file a responsive pleading must be computed from the date of mailing by
43 the ~~{clerk of the court.}~~ *servicing party*. The court may grant an extension of time as
44 may be necessary to afford the management person reasonable opportunity to
45 defend the action.

46 8. In a charter or other writing, a management person or owner of any entity
47 may consent to be subject to the nonexclusive jurisdiction of the courts of, or
48 arbitration in, a specified jurisdiction, or the exclusive jurisdiction of the courts of
49 this State, or the exclusivity of arbitration in a specified jurisdiction or this State,
50 and to be served with process in the manner prescribed in the charter or other
51 writing. Notwithstanding any other provision of this subsection, except by agreeing
52 to arbitrate any arbitrable matter in a specified jurisdiction or in this State, an owner
53 of an entity who is not a management person may not waive its right to maintain a

1 legal action or proceeding in the courts of this State with respect to matters relating
2 to the organization or internal affairs of an entity. Without limiting or affecting the
3 enforceability under the laws of this State governing corporations of any consent or
4 agreement by a management person or stockholder of a corporation, this subsection
5 does not apply to an entity which is a corporation.

6 9. This section does not limit or affect the right to serve process in any other
7 manner now existing or hereafter enacted. This section is an extension of, and not a
8 limitation upon, the right otherwise existing of service of legal process upon
9 nonresidents.

10 10. As used in this section:

11 (a) "Charter" means the articles of organization or an operating agreement of a
12 limited-liability company, the certificate of limited partnership or partnership
13 agreement of a limited partnership or the certificate of trust or governing instrument
14 of a business trust.

15 (b) "Entity" means a domestic:

- 16 (1) Corporation, whether or not for profit;
17 (2) Limited-liability company;
18 (3) Limited partnership; or
19 (4) Business trust.

20 (c) "Management person" means a director, officer, manager, managing
21 member, general partner or trustee of an entity.

22 (d) "Owner" means a member of a limited-liability company, limited partner of
23 a limited partnership or beneficial owner of a business trust.

24 (e) "Registered agent" has the meaning ascribed to it in NRS 77.230.

25 **Sec. 2.** NRS 78.010 is hereby amended to read as follows:

26 78.010 1. As used in this chapter:

27 (a) "Approval" and "vote" as describing action by the directors or stockholders
28 mean the vote of directors in person or by written consent or of stockholders in
29 person, by proxy or by written consent.

30 (b) "Articles," "articles of incorporation" and "certificate of incorporation" are
31 synonymous terms and, unless the context otherwise requires, include all
32 certificates filed pursuant to NRS 78.030, 78.180, 78.185, 78.1955, 78.209, 78.380,
33 78.385, 78.390, 78.725 and 78.730 and any articles of merger, conversion,
34 exchange or domestication filed pursuant to NRS 92A.200 to 92A.240, inclusive, or
35 92A.270. Unless the context otherwise requires, these terms include restated
36 articles and certificates of incorporation.

37 (c) "Directors" and "trustees" are synonymous terms.

38 (d) "Entity" means a foreign or domestic:

- 39 (1) Corporation, whether or not for profit;
40 (2) Limited-liability company;
41 (3) Limited partnership; or
42 (4) Business trust.

43 (e) "*Market value*" when used in reference to the shares or property of any
44 resident domestic corporation, means:

45 (1) *In the case of shares, the highest closing sale price of a share during*
46 *the 30 calendar days immediately preceding the date in question on the principal*
47 *United States securities exchange registered under the Securities Exchange Act*
48 *on which the shares are listed, or, if the shares are not listed on any such*
49 *exchange, the fair market value on the date in question of a share as determined*
50 *by the board of directors of the resident domestic corporation in good faith.*

51 (2) *In the case of property other than cash or shares, the fair market*
52 *value of the property on the date in question as determined by the board of*
53 *directors of the resident domestic corporation in good faith.*

1 *(f) "Publicly traded corporation" means a domestic corporation that has a*
 2 *class or series of voting shares which is:*

3 *(1) A covered security under section 18(b)(1)(A) or (B) of the Securities*
 4 *Act of 1933, 15 U.S.C. § 77r(b)(1)(A) or (B), as amended; or*

5 *(2) Traded in an organized market and that has at least 2,000*
 6 *stockholders and a market value of at least \$20,000,000, exclusive of the value of*
 7 *such shares held by the corporation's subsidiaries, senior executives, directors*
 8 *and beneficial stockholders owning more than 10 percent of such shares.*

9 *(g) "Principal office" means the office, in or out of this State, where the*
 10 *principal executive offices of a domestic or foreign corporation are located.*

11 ~~(h)~~ *(h) "Receiver" includes receivers and trustees appointed by a court as*
 12 *provided in this chapter or in chapter 32 of NRS.*

13 ~~(i)~~ *(i) "Registered agent" has the meaning ascribed to it in NRS 77.230.*

14 ~~(j)~~ *(j) "Registered office" means the office maintained at the street address of*
 15 *the registered agent.*

16 ~~(k)~~ *(k) "Resident domestic corporation" means a domestic corporation that*
 17 *has 200 or more stockholders of record. A resident domestic corporation does not*
 18 *cease to be a resident domestic corporation by reason of events occurring or*
 19 *actions taken while the resident domestic corporation is subject to NRS 78.411 to*
 20 *78.444, inclusive.*

21 *(l) "Securities Exchange Act" means the Act of Congress known as the*
 22 *Securities Exchange Act of 1934, as amended, 15 U.S.C. §§ 78a et seq.*

23 *(m) "Stockholder of record" means a person whose name appears on the stock*
 24 *ledger of the corporation as the owner of record of shares of any class or series of*
 25 *the stock of the corporation. The term does not include a beneficial owner of shares*
 26 *who is not simultaneously the owner of record of such shares as indicated in the*
 27 *stock ledger.*

28 2. General terms and powers given in this chapter are not restricted by the use
 29 of special terms, or by any grant of special powers contained in this chapter.

30 **3. As used in this section:**

31 *(a) "Share" has the meaning ascribed to it in NRS 78.429.*

32 *(b) "Subsidiary" has the meaning ascribed to it in NRS 78.431.*

33 *(c) "Voting shares" has the meaning ascribed to it in NRS 78.432.*

34 **Sec. 3.** NRS 78.045 is hereby amended to read as follows:

35 78.045 1. The Secretary of State shall not accept for filing any articles of
 36 incorporation or any certificate of amendment of articles of incorporation of any
 37 corporation formed pursuant to the laws of this State which provides that the name
 38 of the corporation contains the word "bank" or "trust," unless:

39 (a) It appears from the articles or the certificate of amendment that the
 40 corporation proposes to carry on business as a banking or trust company,
 41 exclusively or in connection with its business as a bank, savings and loan
 42 association, savings bank or thrift company; and

43 (b) The articles or certificate of amendment is first approved by the
 44 Commissioner of Financial Institutions.

45 2. The Secretary of State shall not accept for filing any articles of
 46 incorporation or any certificate of amendment of articles of incorporation of any
 47 corporation formed pursuant to the provisions of this chapter if it appears from the
 48 articles or the certificate of amendment that the business to be carried on by the
 49 corporation is subject to supervision by the Commissioner of Insurance or by the
 50 Commissioner of Financial Institutions, unless the articles or certificate of
 51 amendment is approved by the Commissioner who will supervise the business of
 52 the corporation.

1 3. Except as otherwise provided in subsection 7, the Secretary of State shall
2 not accept for filing any articles of incorporation or any certificate of amendment of
3 articles of incorporation of any corporation formed pursuant to the laws of this
4 State if the name of the corporation contains the words “engineer,” “engineered,”
5 “engineering,” “professional engineer,” “registered engineer” or “licensed
6 engineer” unless:

7 (a) The State Board of Professional Engineers and Land Surveyors certifies
8 that the principals of the corporation are licensed to practice engineering pursuant
9 to the laws of this State; or

10 (b) The State Board of Professional Engineers and Land Surveyors certifies
11 that the corporation is exempt from the prohibitions of NRS 625.520.

12 4. Except as otherwise provided in subsection 7, the Secretary of State shall
13 not accept for filing any articles of incorporation or any certificate of amendment of
14 articles of incorporation of any corporation formed pursuant to the laws of this
15 State if the name of the corporation contains the words “architect,” “architecture,”
16 “registered architect,” “licensed architect,” “registered interior designer,”
17 “registered interior design,” “residential designer,” “registered residential
18 designer,” “licensed residential designer” or “residential design” unless the State
19 Board of Architecture, Interior Design and Residential Design certifies that:

20 (a) The principals of the corporation are holders of a certificate of registration
21 to practice architecture or residential design or to practice as a registered interior
22 designer, as applicable, pursuant to the laws of this State; or

23 (b) The corporation is qualified to do business in this State pursuant to NRS
24 623.349.

25 5. The Secretary of State shall not accept for filing any articles of
26 incorporation or any certificate of amendment of articles of incorporation of any
27 corporation formed pursuant to the laws of this State which provides that the name
28 of the corporation contains the word “accountant,” “accounting,” “accountancy,”
29 “auditor” or “auditing” unless the Nevada State Board of Accountancy certifies that
30 the corporation:

31 (a) Is registered pursuant to the provisions of chapter 628 of NRS; or

32 (b) Has filed with the Nevada State Board of Accountancy under penalty of
33 perjury a written statement that the corporation is not engaged in the practice of
34 accounting and is not offering to practice accounting in this State.

35 6. The Secretary of State shall not accept for filing any articles of
36 incorporation or any certificate of amendment of articles of incorporation of any
37 corporation formed or existing pursuant to the laws of this State which provides
38 that the name of the corporation contains the words “common-interest community,”
39 “community association,” “master association,” “unit-owners’ association” or
40 “homeowners’ association” or if it appears in the articles of incorporation or
41 certificate of amendment that the purpose of the corporation is to operate as a unit-
42 owners’ association pursuant to chapter 116 or 116B of NRS unless the
43 Administrator of the Real Estate Division of the Department of Business and
44 Industry certifies that the corporation has:

45 (a) Registered with the Ombudsman for Owners in Common-Interest
46 Communities and Condominium Hotels pursuant to NRS 116.31158 or 116B.625;
47 and

48 (b) Paid to the Administrator of the Real Estate Division the fees required
49 pursuant to NRS 116.31155 or 116B.620.

50 7. The provisions of subsections 3 and 4 do not apply to any corporation,
51 whose securities are publicly traded and regulated by the Securities Exchange Act,
52 ~~of 1934,~~ which does not engage in the practice of professional engineering,
53 architecture or residential design or interior design, as applicable.

1 8. The Commissioner of Financial Institutions and the Commissioner of
2 Insurance may approve or disapprove the articles or amendments referred to them
3 pursuant to the provisions of this section.

4 **Sec. 4.** NRS 78.046 is hereby amended to read as follows:

5 78.046 1. The articles of incorporation or bylaws of a corporation may
6 require, to the extent not inconsistent with any applicable jurisdictional
7 requirements ~~[(2)]~~ *and the laws of the United States*, that any, all or certain ~~[(internal)]~~
8 :

9 (a) *Concurrent jurisdiction actions must be brought solely or exclusively in*
10 *the court or courts specified in the requirement; and*

11 (b) *Internal* actions must be brought solely or exclusively in the court or courts
12 specified in the requirement, which must include at least one court in this State.

13 2. Unless otherwise expressly set forth in the articles of incorporation or
14 bylaws, ~~[(such a)]~~ *any* requirement *described in subsection 1* must not be interpreted
15 as prohibiting any corporation from consenting, or requiring any corporation to
16 consent, to any alternative forum in any instance.

17 ~~[(2)]~~ 3. The provisions of this section do not create or authorize any cause of
18 action against a corporation or its directors or officers.
