## ORDER DENYING RESPONDENT'S PETITION FOR REHEARING

RESPONDENT Sheila Matherly's ("RESPONDENT Matherly") Request for Rehearing was heard by the Commission for Common-Interest Communities and Condominium Hotels, State of Nevada (the "Commission"), during a regular agenda on December 12, 2023 ("Hearing"). Attorney Vincent Aiello of the law firm Spencer Fane appeared on behalf of RESPONDENT Matherly and Phil W. Su, Senior Deputy Attorney General, appeared on behalf of the Real Estate Division of the Department of Business and Industry, State of Nevada (the "Division").

Attorney Su noted that the Request for Reconsideration was not submitted to the Division until the evening prior to the Hearing date, and that he therefore did not have a fair opportunity to respond to the points raised in that Request for Reconsideration. Attorney Su further noted that pursuant to NAC 116.617(2), the Request for Reconsideration was due within fifteen (15) days of service of the final order, which was submitted for filing on or about October 14, 2023. Accordingly, this Request for Reconsideration was untimely and should not be entertained.
