14 **ORDER**

16 Communities and Condominium Hotels, State of Nevada (the "Commission") during a
17 regular agenda set on a three-day stack beginning at 9:00 a.m. on September 10, 2024 (the
18 "Hearing."). Michael W. McKelleb, with The Law Office of Michael W. McKelleb, appeared
19 on behalf of Bordeaux Homeowners Association, Inc. ("RESPONDENT"). Christal P.
20 Keegan, Deputy Attorney General with the Nevada Attorney General's Office, appeared
21 on behalf of the Real Estate Division of the Department of Business and Industry, State
22 of Nevada (the "Division").

23 Pursuant to the Commission's Order filed June 20, 2024, the RESPONDENT

25 of 56 pages filed the day before the hearings on September 9, 2024, was untimely and could

6 ten (10) business days prior to that meeting.


7 2. If applicable, the Commission requests an opinion from the Deputy Attorney
