Hello Maria Gallo.

I am on the HOA Board at Stanford Square @ Stateline NV 89449. I am requesting a re-hearing for this case (see attached case files)

We were just notified by our present Management Company (Management Trust), that they never picked up the Certified Mail that was sent by your office notifying about an in person case review. Since we weren't present, we received a default ruling/penalty. We were never able to state our case, which we believe the HOA/Board was not at fault.

Briefly, we had a former large managment company (Associa), which didn't forward all the records to the new management company (Managment Trust). We believe they either don't have them or are uncooperative, but we hope they have kept the records which they are suppose to for 1- years. I have left a message with Investigator Pitch detailing our issues with Associa. We also had meetings when Associa suggested, so wasn't aware of specific after hour meeting requirements. We were dropped by Associa and hired Managment Trust, but have had real difficulty getting all of the required records.

Upon being notified from your office about violations, we hired an attorney at the suggestion of Managment Trust to help us, but it seems that very little was done. Between the attorney costs and the penalty fees issued by your office, Stanford Squares HOA budgets will be in a major budget constraint that will force us to raise HOA fees again. We are one of the last lower rent complexes in Lake Tahoe and this would cause more rent increases and hardships for our tenants.

Please let us know if our request for a re-hearing would be acceptable.
