STATUS REPORT

- The Commission ordered Respondent to "pay the costs of the investigation and 1. the hearing in the amount of \$3,818.34 which are actual, reasonable, and necessary within 60 days of entry of Order." Order, at 5:4-6. Respondent timely paid the costs of the investigation and the hearing as ordered by the Commission. Receipt of Respondent's payment is attached herein as Exhibit A.
- 2. The Commission ordered Respondent to "perform a reserve study by a licensed reserve study specialist." Order, at 5:7-8. On or around July 8, 2024, Respondent retained Mari Jo Betterley (Nevada State Permit RSS. 0000025), a reserve study specialist from Better Reserve Consultants, LLC, to conduct a reserve study. In the early weeks of August, Respondent completed the questionnaire for the reserve study, provided aerial photos, documents, and information that is required for a reserve study report. Respondent is still waiting for a report from Ms. Betterley. Meanwhile, Respondent opened a savings account, designated it as a reserve account, and deposited \$2,882.04 into the account. See Reserve Account Statement, attached as Exhibit B.
- The Commission also ordered Respondent to submit to the Commission the 3. following:
 - Bank statements from December 31, 2023 to August 2024; a.
 - Draft budget for 2025; and b.
 - Tax return filings for years 2022 and 2023 C.

See Order, at 5:10-14.

Statements of Respondent's operating account from December 31, 2023 to August 2024 are attached as Exhibit C. Draft budget proposal for 2025 is attached as Exhibit D. Respondent also prepared a financial forecast for 2024, which is attached as Exhibit E. Respondent has no tax return filings to produce for years 2022 and 2023. Respondent's financial report for years 2023 and 2024 are attached as Exhibit F and Exhibit G, respectively.

4. During the meeting on June 12, 2024, Complainant Jon Margalit made an unsupported assertion that the private street inside of Del Rey Estates community (the

"Community") is in disrepair. Following the June 12, 2024 meeting, Respondent contacted J&J
Enterprises ("J&J"), an asphalt paving and maintenance provider, to inspect the private street
inside the Community. After the inspection, an employee of J&J informed Respondent that the
street is not in an urgent need to be repaired or replaced.
