

1. RESPONDENT shall return to the December 3-5, 2024 Commission Meetings and provide information previously requested in its June 20, 2024 Order, specifically:

- a. Approved reserve study;
- b. Adopted budget for 2025; and
- c. Determine with a CPA if tax returns are required for this Association, and to provide that information to the Commission.

2. RESPONDENT shall also consider a management company.


3. RESPONDENT shall provide a status report submitted no less than ten (10) business days prior the Commission Meeting.

4. Pursuant to NRS 116.785, if the RESPONDENT violates any Commission order, the Commission may impose an administrative fine of not more than \$1,000 for each violation.

5. The Commission retains jurisdiction for correcting any errors that may have occurred in the drafting and issuance of this document.
