Hello Ms Bates, Ms Carrillo & Mr. Moorer.

Thank you for letting me know about the denial of my Instructor application. This is a formal appeal for you to reconsider the denial as teaching Real Estate is my passion and I have been doing it for a while at Real Estate School of Nevada and then recently at CSN. I have been a real estate agent since 1993 and Broker since 2003. My record was spotless until 2022 when I Opened TR realty centennial.
