## Mr. Dayal:

A full introduction does not appear necessary, since we are familiar, as I was the deputy attorney general that brought the previous cases against you in case nos. 2021-422, 2021-1115 and 2022-49. I am disappointed that since the February 25, 2023 Commission's Order for Global Settlement of Disciplinary Action in case nos. 2021-422, 2021-1115 and 2022-49, you failed to make any of the monthly payments and subsequently engaged in acts which require a valid real estate licenses and permits, which as you know, you voluntarily surrendered as part of the Stipulation.

Therefore, a Complaint was filed against you on April 9, 2025, for your unlicensed acts committed upon the complainant, a Nevada Assemblyman. The Complaint and Notice of Hearing, the Notice of Complaint and Obligation to Response, and Notice of Documents with Division's documents bate stamped pages NRED 000001-000108 were certified mailed to you at the various addresses the Division has on file for you and additionally attached here as well.
