Ms. Flores stated that she wanted an open session.

Ms. Clark stated that the Division received Ms. Flores' real estate salesperson application and pursuant to NRS 645.330(1)(a)(b), NRS 645.330(2)(a), and NAC 645.095(1)(d) denied her application.

Ms. Flores was sworn in.

Ms. Flores gave her statement.

Motion

Commissioner Tina moved to approve Wendy Flores' appeal file number S-LDA-25-015 and grant her a license. Seconded by Commissioner Spires. Motion failed 2:3 with Commissioners Raynor, Barbee, and Ruthe opposed.

**4-A) Discussion regarding the Administrator's Report**

Administrator Sharath Chandra reported continued progress on the Division's technology project. Mr. Chandra stated that the project is approximately at the midway point with work now focused on the education component. Mr. Chandra stated that the next major phase will be testing, and the Divisions consultant is actively supporting and helping to accelerate the project. Mr. Chandra reported that staff from the administrative, licensing and education sections, are participating in workflow reviews. Mr. Chandra stated that the Division remains in communication with the Colorado Division of Real Estate, which uses the same technology partner. Mr. Chandra stated the long-term goal is to move all applications, transactions, and payments online while continuing to offer in-person assistance for those who need it. Mr. Chandra stated that additional plans include installing an office kiosk to provide real-time support from a licensing processor. All efforts are aligned with transitioning to a fully online platform.

Mr. Chandra informed the Commission that the Division is preparing for the upcoming legislative session, with a special session expected to address several priority bills. Mr. Chandra stated the Governor's office is prioritizing broad public needs such as benefits, medical

services, policing, and safety. Mr. Chandra noted that during crises, general funds are often redirected to address urgent statewide concerns. Mr. Chandra emphasized the goal of creating long-term stability for the Division and its licensees. Mr. Chandra stressed the importance of ensuring that collected fees remain within the Division to directly benefit licensees. Mr. Chandra stated an expansion of services increase the Division's value and strengthens the justification for fees. He Mr. Chandra reported that historically, the Division generated more revenue than it spent, but rising costs and economic changes have narrowed that gap. Mr. Chandra stated that remaining in the general fund is no longer financially practical, as future crises could result in significant budget cuts. Mr. Chandra stated that the Division aims to build a reserve to avoid reducing staff or services during future downturns. Mr. Chandra stated the technology fee has helped stabilize funding for system upgrades and online service expansion. Mr. Chandra also reported that statutory language has been added to ensure technology-related funds are protected from being swept into the general fund.

Mr. Chandra reported that the Division has presented its financial and operational case to the Governor's office. Mr. Chandra stated that the Director supports the Division's position, but internal advocacy will still be required to advance the changes needed. Mr. Chandra stated that although external support has been consistent, the Division must continue reinforcing its value and long-term sustainability. Mr. Chandra emphasized that future leadership should inherit a strong, stable operation—not one facing financial uncertainty.

President Ruthe commented.

Commissioner Barbee questioned Mr. Chandra and commented.


